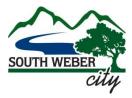

#### GENERAL

These new requirements require the capability of measuring water use more precisely than in the past. Due to this new requirement, master meters need to be placed at key location in the water system. One of these locations is on the feed line to the Westside Reservoir.

Ormond Construction was previously awarded the contract for the Westside Reservoir Improvements Project in the amount of \$106,569.74. Due to this new metering requirement and Ormond's familiarity with the site and piping, Jones and Associates designed a meter vault and requested change order pricing from Ormond. No meter will be installed at this time. This work will provide the needed vault and piping for the installation of a future meter.

#### BUDGET

While this change order is under the Westside Reservoir Improvements Project contract, the cost of the work to be performed should be attributed to metering. The 2019-2020 budget contains a project for SCADA and metering. After this change order, the remaining balance for upgrading the SCADA and installing the remaining meter infrastructure is \$215, 383. A summary is as follows:

We have reviewed the change order pricing and feel it is reasonable. Due to the lead time on the vault, the contract time will need to be extended for 35 days.

Overall, we recommend that the Council approve Change Order #1 in amount of \$34,617.48.

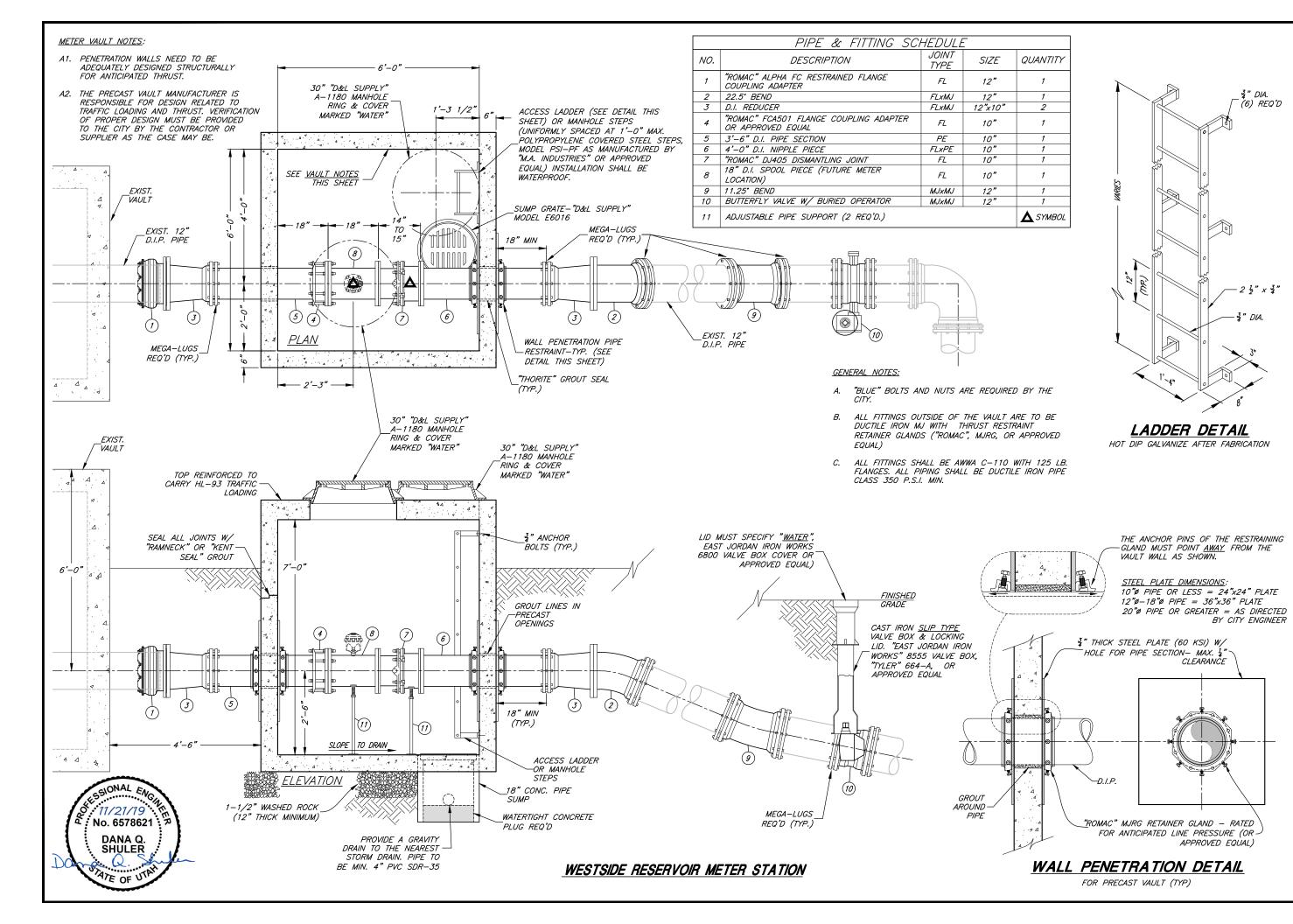

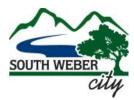

They would also like to recommend a moratorium until all zoning codes are reviewed. In keeping consistency in the zone, staff is recommending the name be changed to Residential Multi-Family (R-7)

### R-H ZONE AMENDMENTS MEMO By Barry Burton 11.8.19

## Purpose:

The reason this proposal is before the Planning Commission is two-fold. One is to give the zone a new name; one that will be more descriptive of what the zone allows and one that is less controversial than *"high density."* Many cities name their zones based on the minimum lot size allowed; R-1-10 for a zone allowing one dwelling per lot and requiring a minimum of 10,000 sq. ft. etc. Those cities have a lot size-based ordinance. Our ordinance is density based. That is to say, the minimum lot size allowed in any zone is far less than the average lot size must be achieved in order to meet the maximum density. For instance; The minimum lot size in the R-M zone is 9,000 sq. ft. while the maximum density is 2.8 dwellings per acre. In order to meet that density requirement, the average lot size would be closer to 12,000 sq. ft. So, naming the zone R-1-9 would be somewhat confusing.

Another option would be to name the zone based on the maximum density; R-1-2.8 instead of R-M. Or, R-M-13 instead of R-H. In this instance the M stands for multi-family and 13 the density. We could also simplify all the zones to something like R-1, R-2, R-3, where the number simply designates a different residential zone and has nothing to do with the lot size allowed or the type of residential units allowed.

The other purpose in amending the R-H zone is to designate a density that is less than the 13 dwelling units per acre now allowed. We can recommend any number you choose. I will have visual examples of various residential densities for you to consider at the meeting.

**Public Hearing & Action on ORDINANCE 19-16 Amending South Weber City Code Title 10 Chapter 5 Article C: (R-H) Residential High-Density Zone:** City Planner, Barry Burton stated the reason this proposal is before the Planning Commission is two-fold. First, to give the zone a new name that will be more descriptive of what the zone allows and is less controversial than "high density." He pointed out many cities name their zones based on the minimum lot size allowed; R-1-10 for a zone allowing one dwelling per lot and requiring a minimum of 10,000 sq. ft. etc. Those cities have a lot size-based ordinance. Barry presented visual examples of various residential densities to consider. Cambridge Crossing in South Weber City is 13 units per acre. Briar Ridge in South Ogden is 10.9 units per acre. Freedom Landing Townhomes in South Weber City is 10.6 units per acre. Seasons at the Ridge in South Ogden is 8.7 units per acre with a total of 106 units. Riverside Place in South Weber City is 4.2 units per acre.

Commissioner Osborne asked if there was any public comment.

Julie Losee, 2541 E. 8200 S., voiced 13 units, such as Cambridge Crossing, is a maximum number that the city needs.

Kathy Devino, 2480 E. 8300 S., asked about the density for the Lofts. Barry stated this won't affect the Lofts Subdivision.

**Hayley Alberts, 7560 S. 1740 E.,** suggested the maximum number of units to be 4 to 5 units per acre. She feels South Weber needs to have more open space with a country feel. She feels larger lots can be what this city has to offer individuals looking for that.

Commissioner Grubb moved to close the public hearing for ORDINANCE 19-16 Amending South Weber City Code Title 10 Chapter 5 Article C: (R-H) Residential High-Density Zone. Commissioner Walton seconded the motion. Commissioners Grubb, Pitts, Osborne, Walton, and Johnson voted aye. The motion carried.

Barry explained the proposal is to amend the existing R-H Zone by name and density. Commissioner Grubb asked about the effects of renaming, property already zoned, etc. Commissioner Osborne pointed out the R-H Zone allowed Petersen Farms to happen, but also allowed other developments that the city doesn't particularly like. Barry commented the City Council did direct the Planning Commission to look at the number or density. Commissioner Walton pointed out the slide examples are evidence of closed off neighborhoods. He is hoping with the zone there can be more open space reserved. Commissioner Osborne doesn't feel the city has enough large parcels in the city. Commissioner Walton disagreed. Barry explained most of the examples are PUD's. Commissioner Grubb pointed out the minimum lot size goes against minimum unit clustering. Commissioner Walton feels the general plan needs to identify areas the city wants to preserve as open space. Councilman Halverson discussed the bigger picture of this being a whole new philosophy for the city. Commissioner Osborne understands this decision will move us into looking at other areas. Commissioner Grubb believes in open space and feels the R-H Zone is good for multi-family units, but if the city needs to take it from 13 units down, he would suggest a number of 6 to 8 units per acre. He doesn't know if the details of all the high density need to be considered at this point. Commissioner Osborne and Johnson suggest 6 units. Commissioner Pitts and Grubb suggested 8 units. Commissioner Walton suggested 8 to 10 units. Commissioner Walton feels it is more important to define a vision for the zone verses the density.

Commissioner Johnson moved to amend ORDINANCE 19-16 Amending South Weber City Code Title 10 Chapter 5 Article C: (R-H) Residential High-Density Zone to no more than 6 units per acre. Motion died due to lack of a second.

Commissioner Grubb moved to amend ORDINANCE 19-16 Amending South Weber City Code Title 10 Chapter 5 Article C: (R-H) Residential High-Density Zone to no more than 8 units per acre. Commissioner Pitts seconded the motion. Commissioners Grubb, and Pitts voted aye. Commissioner Walton, Osborne, and Johnson voted no. The motion died 3 to 2.

Commissioner Walton voted no because he feels it is more than just defining a number but a bigger picture of the zone. Commissioner Osborne would like to establish this so that it can be

talked about with the general plan. It was stated this is a larger discussion as it relates to the general plan. The Planning Commission suggested a possible moratorium during this period of review.

Commissioner Johnson moved to amend ORDINANCE 19-16 Amending South Weber City Code Title 10 Chapter 5 Article C: (R-H) Residential High-Density Zone to no more 7 than units per acre and title it R-U-7. Motion died due to lack of a second.

Commissioner Grubb moved to recommend to the City Council amend ORDINANCE 19-16 Amending South Weber City Code Title 10 Chapter 5 Article C: (R-H) Residential High-Density Zone to no more 7 than units per acre and title it the R-7 Zone with the recommendation no property be rezoned or developed during the moratorium period. Commissioner Walton seconded the motion. Commissioner Johnson, Pitts, Walton, Grubb, and Osborne voted aye. The motion carried. #### ORDINANCE 19-16

#### AN ORDINANCE OF THE SOUTH WEBER CITY COUNCIL AMENDING THE RESIDENTIAL HIGH-DENSITY (R-H) ZONING DISTRICT TO RESIDENTIAL MULTI-FAMILY (R-7)

**WHEREAS**, the Residential High Density (R-H) zoning district exists to provide for neighborhoods of varying degrees of density, to promote an intensively developed residential environment suitable primarily for adult living, and to provide alternate forms of residential living ranging from single-family to twelve-family dwellings and necessary public services; and

**WHEREAS**, the Planning Commission held a public hearing on November 14, 2019 on the issue of amending the R-H zoning district to reduce the density from 13 units per acre to seven, and to change the name to Residential Multi-Family (R-7) and has recommended to the Council that the amendment be made; and

**WHEREAS**, the Council finds and determines that amending the R-H Zoning District to limit its density to seven units per acre is in the best interest of the City and will provide for the health and welfare and good order of its citizens;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of South Weber City, State of Utah:

**Section 1. Title Amended:** TITLE 10 CHAPTER 5: ZONING DISTRICTS ARTICLE C. RESIDENTIAL HIGH-DENSITY ZONE (R-H) shall now be TITLE 10 CHAPTER 5: ZONING DISTRICTS ARTICLE C. RESIDENTIAL MULTI-FAMILY SEVEN ZONE (R-7)

**Section 2. Section Amended**: Section 10-5C-5 of the Residential High-Density Zone (R-H) of the South Weber City Code is hereby amended to read:

### **10-5C-5: BUILDING LOT REQUIREMENTS:**

- A. Density: There shall be no more than seven dwelling units per acre contained within the boundaries of each phase of every development; except when previously completed phases of the same development have sufficiently low density so that the average is still seven dwelling units per acre or less.
- B. Lot Area:
  - 1. There shall be a minimum of twelve thousand (12,000) square feet in each lot on which a single-family or two-family dwelling is built.
  - 2. There is no minimum lot area for other dwelling types, but the density requirement listed above must be adhered to in all cases.
- C. Lot Width: Each lot shall have a minimum width of one hundred feet (100').

**Section 3: Section Amended:** Section 10-5C-10: SPECIAL CONDITIONS of the Residential High-Density Zone (R-H) of the South Weber City Code is hereby amended to read:

#### ORD 19-16 R-H Zone

## 10-5C-10: SPECIAL CONDITIONS:

Due to the higher residential densities permitted by this article, the following conditions are required in order to assure a quality livable environment:

- A. Minimum and Maximum Area: The minimum area that may be zoned R-7 shall be two (2) acres and the maximum area which may be zoned R-7 in any zone district shall be nine point five (9.5) acres.
- B. Open Space: Multi-family dwellings shall provide usable functional open space for outdoor leisure in the following amounts:
  - 1. Eight hundred (800) square feet per unit for one- and two-family dwellings;
  - 2. Six hundred (600) square feet per unit for three- and four-family dwellings; and
  - 3. An additional four hundred (400) square feet per dwelling unit for each additional unit over four (4).
- C. Outdoor Storage Space: Three-family, four-family and multi-family dwellings shall provide enclosed outside storage space of at least thirty (30) square feet for each dwelling unit. (Ord 2000-9, 7-11-2000)

**Section 4: Section amended:** Section 10-5C-11: LANDSCAPING REQUIREMENTS of the Residential High-Density Zone (R-H) of the South Weber City Code is hereby amended to read:

Section 10-5C-11: LANDSCAPING REQUIRMENTS:

- A. General Landscaping: At least fifteen percent (15%) of the total site shall be thoroughly landscaped, including an irrigation system to maintain such landscaping. Landscaping shall meet the requirements of chapter 15 of this title. For use of exceptional design and materials, as determined by the Planning Commission, the landscaping may be reduced to ten percent (10%) of the total site.
- B. Fencing: A six-foot (6') tall solid screening fence shall be required between the Residential Multi-Family (R-7) Zone and all lower density residential zones. (Ord 18-05, 8-14-2018)

Section 5: Section amended: Section 10-5C-115 of the South Weber City Code is hereby amended to read:

### **10-15-2: GENERAL REQUIREMENTS:**

A. Required: All land approved for development in the city shall be constructed as required by city ordinances and the planning commission or city council. In order to control the potential for adverse conditions resulting from dust, mud and erosion, land remaining on developed sites that is not covered with structures or impervious surfaces such as

driveways, walks, courts, landscape features (sculptures, boulders, etc.), shall be landscaped in accordance with this chapter and when applicable irrigated with an appropriate system to maintain plants in a healthy, growing condition, compatible with the general neighborhood appearance.

B. Residential Front, Side, And Back Yard Areas: Landscaping shall be installed in all residential front yards, side yards, and back yards in residential low-moderate (R-LM), residential moderate (R-M), and Residential Multi-Family (R-7)\_zones. Front and side yard landscaping shall be completed within eighteen (18) months of occupancy. Back yards shall be landscaped within twenty-four (24) months of occupancy. Landscaping of a residential site shall include an irrigation system sufficient to maintain the health and beauty of the landscaping. Residents who fail to abide by these landscaping regulations are subject to penalties as set forth in section <u>10-15-8</u> of this chapter.

Section 5. General Repealer. Ordinances in conflict with this ordinance are hereby repealed to the extent of such conflict.

**Section 6. Effective Date**. The City Council of South Weber City, State of Utah, has determined that the public health, safety and welfare requires that this ordinance take effect immediately. Therefore, this ordinance shall become effective immediately upon passage and publication as required by law.

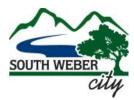

## ORDINANCE 19-17

## AN ORDINANCE OF THE SOUTH WEBER CITY COUNCIL AMENDING CITY CODE 10-7-2 REGARDING CONDITIONAL USE PERMIT REQUIREMENTS

**WHEREAS**, Utah Code Ann. 10-9a-507(1)(a) provides that a municipality may adopt a land use ordinance that includes conditional uses and provisions for conditional uses that require compliance with standards set forth in an applicable ordinance; and

**WHEREAS**, the Planning Commission has considered a proposal to prohibit applications for conditional use permits for two years following the revocation of a conditional use permit at the same address, for the same applicant, or for the same purpose, and has recommended to the Council that the same be adopted; and

**WHEREAS**, the Council finds it is in the best interest of the City to amend City Code 10-7-2 to include such a provision, and to make additional technical amendments to such section;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of South Weber City, State of Utah:

Section 1. Section Amended. South Weber City Code Section 10-7-2 is hereby amended to read:

## **10-7-2: CONDITIONAL USE PERMIT REQUIRED; REVOCATION:**

- A. A conditional use permit shall be required for all uses listed as conditional in the land use regulations.
- B. A conditional use permit may be revoked by the City Council after a review and recommendation by the Planning Commission, upon failure to comply with the conditions imposed with the original approval of the permit.
- C. An application for a conditional use permit is prohibited for two years following the revocation of a conditional use permit at the same address, for the same applicant, or for the same purpose.

Section 2. General Repealer. Ordinances in conflict with this ordinance are hereby repealed to the extent of such conflict.

**Section 3. Effective Date**. The City Council of South Weber City, State of Utah, has determined that the public health, safety and welfare requires that this ordinance take effect immediately. Therefore, this ordinance shall become effective immediately upon passage and publication as required by law.

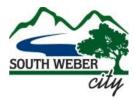
#### Background

Public Hearing (show-cause) and Action on Short Term Rental Conditional Use Permit Revocation: Cobblestone Resort located at 1923 E Canyon Drive South Weber UT 84405 (Parcel ID# 13-184-0030) 1.14 Acres: Tanner Clagett, attorney in Bountiful, explained he was contacted this week by Dustin Shiozaki to represent him. Commissioner Osborne explained recently the City passed an ordinance allowing for short term rentals within the City with the approval of a conditional use permit. This property owner has received three strikes. Tanner voiced he has received copies of the three strikes and has expressed to Dustin it is within his interest to comply with the city code. He understands this. One of the reasons he hired Tanner is to get in compliance and make sure he is doing what he needs to do. Tanner has spoken to Dustin about Strike #3. He understands Dustin is involved in a boudoir business. He informed him that somewhere along the line the property address came to be on that website. He said that has been removed and there is no operation of a business that falls under a sexually oriented business by the city's definition. He understands there has been off street parking. He said Dustin tries very hard to inform renters of the parking restrictions. Tanner explained Dustin has expressed an interest to comply and work with the City.

Chris Tremea, Code Enforcer, discussed the short-term rental committee who helped draft the short-term rental ordinance which was adopted on 8 August 2019. Prior to August, Chris communicated with Dustin because he received a lot of normal nuisance complaints, even outside of the short-term rental. He reported parking in the street and on the grass has been an issue as well as there were several noise complaints. During this process the upstairs was being used with the downstairs being under construction. The conditional use permit allowed for either upstairs or downstairs being rented but not both. He pointed out there have been times when as many as 50 vehicles are at this short-term rental with vehicles blocking resident's driveways. He said all these complaints have been discussed with Dustin. He said there have been times when the Davis County Sheriff's Department has been contacted. He voiced there have been numerous warnings given and nuisance violations.

Chris explained Strike #2 included parking violations; noise afterhours, and pool use afterhours. He described a time where there were 36 people going in and out over a weekend time frame. He then discussed Strike #3. He said there was an incident in late June or early July in which a blue tarp was put up around the pool. There was someone taking pictures of a topless lady in the pool. This was seen by a resident. Chris did talk to a renter who said a photo shoot was going on. He explained a resident texted him concerning information received on the internet concerning a boudoir business that was being advertised at the short-term rental. He and a deputy reviewed information received, and it was obvious this business was operating as a sexually oriented business.

Chris discussed the events of a couple of weekends ago in which the Davis County Sheriff's Department was involved with and has documentation. Chris said he did not give a Strike #4. He said attempt for compliance has been deceitful, and non-compliant by both the property owner and the business owner. He knows there are a lot of citizens who are extremely concerned for their property. Tanner asked about one floor only being used. Chris said there is only one rental agreement with one party up to 18 people. Commissioner Osborne said the number 18 came from the Planning Commission and discussion with the owner concerning what would be a fair number. He explained the Planning Commission looks at number of square footages, parking, and number of beds to come up with the occupancy number. Tanner commented he hopes that by him being here is evidence that Dustin is trying to address some of these issues. He said Dustin has provided a memo of what his obligations are to be. He did discuss the boudoir photography with Dustin and there is no longer photography going on. Chris explained he asked Dustin specific questions about the photography and he said they were not aware of the photography. He feels there was deceit.

Commissioner Osborne asked if there was any public comment.

**Jeff Bench, 1916 East Canyon Drive,** wishes no ill-will on anyone, but the situation has not improved. He expressed his frustration after last weekend he had to clean up beer bottle and cans from his yard. He doesn't see that anything will adjust and change. He doesn't see any positive to the City of South Weber, neighbors, or community for this to continue. He encouraged the Planning Commission to revoke the license.

**Thomas Wright, 1934 East Canyon Drive,** stated there is a lot of documentation over the problems at this property. He expressed this is similar to a cancer invading your life. He pointed out if this was in front of your house you would do everything you could to get rid of it.

**Misti Lopez, 1191 East Canyon Drive,** explained there are other VRBO's in the City that don't have these issues. She knows they can be run respectfully. She commented just because there is something happening in one, doesn't mean that is happening everywhere. She expressed there are ways to run a business and be successful.

**Sandra Layland, 7294 S. 1950 E.,** understands there are well ran VRBO's in the City. She has attended meetings when they were granted, and she wished they were next to her home verses the existing short-term rental next to her home. She has attended many City Council and Planning Commission meetings. She has proof that Dustin has information on the Air B&B website and VRBO that advertises a lower level apartment. She also has reviews from someone who rented the basement while there was someone else renting the upstairs. She explained how difficult it is for the neighbors who live in this area. She said there is also a new subdivision going in next to this short-term rental. She feels the owners have had enough chances. She said we have reported violations and presented information to the City. She asked for the Planning Commission to revoke the conditional use permit because their pattern of behavior is not to be honored. (SEE ATTACHED)

**Paul Sturm, 2527 Deer Run Drive,** explained when the application for conditional use permit for this short-term rental was being discussed at the Planning Commission meeting on 8 August 2019, there were also other applicants for short term rentals on the same agenda. He feels the Planning Commission treated each one of them fairly.

Commissioner Grubb moved to close the public hearing for action on Short Term Rental Conditional Use Permit Revocation: Cobblestone Resort located at 1923 E Canyon Drive South Weber UT 84405 (Parcel ID# 13-184-0030) 1.14 acres. Commissioner Johnson seconded the motion. Commissioners Grubb, Pitts, Osborne, and Johnson voted aye. The motion carried.

Sergeant Pope, of Davis County Sheriff's Department, reported the following activity at the Cobblestone Resort:

April 25<sup>th</sup> unknown guest with argument back and forth with owners and contractors June 8 lewdness – topless in pool June 27<sup>th</sup> vandalism to pool Sept 23<sup>rd</sup> victim was burglarized Sept 25<sup>th</sup> request for extra patrol Oct 3 agency assist Oct 12 multiple police vehicles arrived for underage drinking/ 11 citations were given for illegal consumption/21 offenders/ 10 officers responded

Commissioner Grubb moved to revoke immediately the Short Term Rental Conditional Use Permit for Cobblestone Resort located at 1923 E Canyon Drive South Weber UT 84405 (Parcel ID# 13-184-0030) 1.14 acres based on non-compliance of the conditional use permit issued on 8 August 2019, namely parking, occupancy, multiple unlicensed businesses & contracts, activity not appropriate with a business in a residential neighborhood, and continued lack of effort to comply or conform with the South Weber City ordinances. Commissioner Pitts seconded the motion. Commissioners Grubb, Pitts, Osborne, and Johnson voted aye. The motion carried.

Commissioner Johnson recommended the City staff send a letter to Air B&B stating the conditional use permit has been revoked. Commissioner Grubb stated the property owner can always reapply for another conditional use permit, but if they continue use, it will become a civil matter.

#### PLANNING COMMISSION ITEMS:

**Commissioner Grubb:** pointed out last night's meeting was nice. He attended a nice workshop today. Hopefully, Wasatch Front and UDOT listened to what we said.

Commissioner Johnson: thanked the citizens who showed up at last night's meeting.

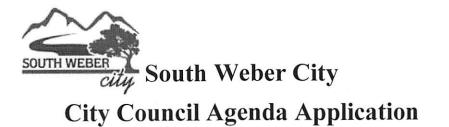
**Commissioner Osborne:** discussed how much he appreciates the communities help with this agenda item.

Subject: General Plan - Sensitive Lands

Dear Council and Planning Commission,

Federal environmental law (CERCLA) establishes, in 42 USC Chapter 103 subchapters 9601 and 9607, that: (1) every owner of property where "a hazardous substance has come to be located" thereby owns a "facility;" and that (2) "owners (both current and former)" and "operators" of such facilities are deemed to be "Potential Responsible Parties (PPPs)" regarding the pollution at issue. CERCLA is particularly harsh towards such owners and operators who profess ignorance of their situations.

This ignorance of affected polluted-property owners in our City has been greatly exacerbated by the diminutive and grossly inaccurate sensitive-land maps (regarding where hazardous substances have 'come to be located') within the City's General Plan. Those affected property owners could well argue that they had cause to rely on their elected and appointed City officials on such a complex and technical matter. All officials swear to promote and safeguard the health and welfare of present and future residents. Moreover, City ordinances authorize our Planning Commissioners to do whatever 'it takes' to measure up to the high standards of their official positions.

However, a review of the City's written and oral records on the subject of HAFB pollution, shows that most of our City officials (present and relatively-recent past) have not even read or otherwise reached a comprehensive appreciation of even the most basic aspects of the Superfund/NPL-level threats relating to our valley. The diminutive plume maps in our General Plan currently and proposed for continuation in our next one, are prime examples of this critical deficiency. Those are collectively many times smaller than defined by the Air Force, EPA and the State of Utah just for the Operable Unit One (OU1) plume as shown on page 1-1 (item 1.0.0.6.) in their 1998 ROD. This plume, much like the one described by the Army Corps of Engineers a decade earlier, showed virtually the entire western portion of our City as where "hazardous substances have come to be located."

The mystery is: How did our City ever create a General Plan with diminutive plume maps which so radically contradict the relatively huge affected land mass defined by the polluter, EPA and the State of Utah? Did the City conjure those tiny maps from thin air, or did it rely on some source still willing to validate this controversial conclusion? Does the City contend that the remedial plan, enacted through the 1998 ROD, worked as promised to restore our valley to its pre-polluted condition by 2010? However, studies since 2010 show that the remediation promised in 1998 failed. New projections predicted that full remediation was not probable "until some uncertain time in the

2040s." After the failure of the 1998 ROD, did HAFB/EPA/UDEQ or any other entity solicit (and share with the City) another environmental audit to ascertain whether any significant portion of the polluted area in our City (in accord with the plume described above in 1998 ROD) had, in fact, been restored from the existence and/or continue threat of pollution migrating from HAFB? If so, please share it with everyone. If such a study had been undertaken, we would have likely participated in it as most of the pollution at issue passes first through our properties on its way to pollute others.

While CERCLA faults passive and willful ignorance of owners and operators of facilities, none of them swore and oath to safeguard their present and future neighbors. Each of you should shoulder much of their blame. They had cause to trust you to perform your sworn duties and responsibilities. Your actions and inactions (see recent letter to RAB copied to the City) created hundreds and potentially thousands of more human receptors of the Base's pollution with all the risks inherent to such exposures. You further helped create, with the developers, hundreds of new PPPs with all the potential legal liabilities this entails. Unfortunately, even if you had the will and inclination to reverse your past legislative recklessness (and you should try), much of the potential damage has already been established through your increases in human density within the polluted areas of our City.

The only thing that our Coalition can do at this stage (after trying unsuccessfully for decades to compel genuine remediation) is to warn those the City has been complicit in endangering both with Superfund/NPL-level pollution and its associated potential legal liability. As PPPs ourselves, our advisers claim that we have an obligation to warn those downgrade about the problems cited above. We have done some of this in the past, but the City's large and yet anticipated influx of new threatened subdivisions means that we still have much more such work ahead of us.

Include this letter with the documentation being collected in conjunction with preparation/approval of the updated General Plan. Also, consider this as a formal request to discuss this topic (for up to 10 minutes) in future meetings with both the Commission and the Council where the updated General Plan is a primary topic on the agenda. Please let me know if you have questions or observations concerning this letter.

Subject: Potential Responsible Parties (PPP)

Dear RAB Members,

My brother was the first, almost 60 years ago, to identify pollution leaking from HAFB into the South Weber valley. Our family and the South Weber Coalition have been working for decades since then to promote proactive remediation of this problem; and to educate the affected public regarding this threat. I first served on the Base's initial Technical Review Committee (TRC), and then for years as a charter member of your Restoration Advisory Board (RAB) which later replaced the TRC. Throughout this and subsequently through reviews of most of your meeting minutes, there seems to have been an avoidance of the subject referenced above. This letter is a request for the RAB to remedy this, and then to hopefully help educate those you represent with the results of your review.

Our attorneys warned us from the outset that we should expect to share responsibility for the pollution migrating through our properties on its way to pollute others within the valley. Federal Environmental laws (CERCLA) in 42 USC Chapter 103, Subchapter 9601 (9) (B) defined all such tainted properties as a 'facility' because "a hazardous substance has come to be located" there. The liability for being thus polluted is defined in 42 USC Chapter 103 Subchapter 9607 (a) (1). 'Owners' and operators' (including current and former ones) of a 'facility,' are deemed to be "Potential Responsible Parties (PPPs)." The 1998 ROD for Operable Unit One (OU1), Page1-1, item 1.0.0.6., shows that the "plume associated with the on-Base Source Area disposal sites has migrated approximately 2200 feet north/northeast of the Base property boundary." This description essentially echoed the conclusions of the Army's Corps of Engineers which mapped the same plume a decade earlier. It found further that this migration ultimately reached the Weber River and virtually the entire western part of the City of South Weber. The Corps findings were shared with the Base, State officials and residents in a well-attended meeting in the City's elementary school. This scope/extent of contamination has not been amended subsequently. Therefore, every current and former 'owner' (since contamination) of a 'facility' within the plume so identified above, is a Potential Responsible Party, as expressly defined in specific Federal statutes.

There is a large amount of reliable readily-available legal requirements, reviews, opinions and case histories relating to potential liabilities for PPPs. One can learn much from simply 'googling' CERCLA then checking sub-categories of Potential Responsible Parties, ignorance, strict liability, joint liability, property transfers, potential-lender liability; etc. A few of many germane indisputable conclusions

such an exercise will produce include: (1) CERCLA "makes passive, willful and other forms of ignorance a liability and rewards informed responsible action." (2) There is a "duty to disclose (facility) contamination before transfer" if not "such a defendant shall be treated as liable under section 9607 (a) (1) with no defense under Section 9607(b) (3) shall be available to the defendant." (3) "Did the owner/operator act reasonably to avoid or mitigate harm?" This inquiry is viewed under a "strict liability" standard for all PPPs.

A wealth of PPP-related knowledge can be gained simply, as cited above, but our family felt this was too serious and technical just for self-reliance. We accordingly hired three lawyers over the years to study this issue and to provide advice regarding how we should address the HAFB pollution located upon and still threatening our properties plus others near our own. They advised us mainly concerning: (a) what we could and shouldn't raise/grow on our contaminated properties, (b) that we should proactively push for genuine remediation of the pollution at issue, (c) to do nothing which could compromise or promote the migration of the pollution towards others and (d) to warn those near and downgrade from us that pollution had flowed (and continues to flow) through and under ours to pollute their properties, and (e) to suggest they study all the implications relating to this.

However, a basic concern our attorneys volunteered in addition was their united opinion that we, and other polluted-property landowners, might well be the primary targets regarding any potential successful litigation for damages relating to the Base's migrating pollution. They argued that such litigation against HAFB was protected under the Federal Tort Claims Act (FTCA). This means, under the Doctrine of Sovereign Immunity, that the Federal Government cannot be sued without its express permission. Any claimant would have to establish that 'negligence' was the causal factor for the alleged injury at issue. Ignorance and certainly thoughtlessness were factors for the Base's dumping of its pollution "all along the hillside" above our valley. However, interviews showed that those doing this disposal were generally uninformed regarding the substances being dumped. Moreover, there is not a shred of evidence that anyone disposing of the Base's pollution knew beforehand that their actions would cause the severe risks ultimately found to warrant the Base's Superfund Site/National Priority Listing (NPL) designations. Therefore, a charge of 'negligence' seems inappropriate.

We later learned that 'owners' of 'facilities' were further hurt by Congressional action which provided military polluters (including HAFB) with a 'Discretionary Function Exception (DFE).' This made actual remediation of the Base's pollution a discretionary rather than a mandatory requirement. This exception was upheld when challenged in Federal District Court (see Waverly View Investors, LLC vs. USA, Civil # CCB-14-1527, 13 Jan 2015). Feedback from other oversight entities shows no example where a military polluter has exercised its 'discretion' to fully remediate the pollution it has generated. Furthermore, most of them are charged with manipulating statistics and studies to imply promising remedial enhancements although without much measurable substance. A common means for this is to provide diminutive plume maps which can then be readily but inaccurately construed as 'amendments' to ROD-defined-pollution-plume maps.

Local newspapers (still available for review) documented admissions, after Hill AFB was declared a Superfund site, that it too had been "less than candid" when dealing with the public. Part of this was its continued public insistence that the springs on our hillside were absolutely safe for drinking. Documents later acquired through a FOIA request, however, proved that the Base's own sponsored

research showed indisputably that, the spring-water at issue, was "not fit for human or animal consumption." One of those springs was once the source of culinary water for an elementary school, several homes and countless other men, women and children for over a century. The dates of the FOIA-provided-proof showed that the Base knew of this 'unfit' condition throughout its many years of contrary denials.

Because of their Congressionally-allowed Discretionary Function Exception and the widespread inaction and misdirection that it enabled; military polluters can no longer be taken seriously regarding any supposed future efforts to genuinely remediate their pollution. Genuine remediation, if possible at HAFB, which is debatable, is very expensive. The HAFB 1998 ROD for OU1 shows that it would cost almost \$306 million to affect timely and effective remediation of just that one operable unit. However, the Base chose an extremely cheaper remedial alternative which was to restore our valley to its pre-polluted condition by 2010 if it worked as advertised. But it failed. The premise for the cheap remedial choice was faulty. Rather than working diligently to create a better premise without such overwhelming flaws, the Base/EPA/UDEQ mainly doubled down on their failed plan by primarily saying more time (until some uncertain time in the 2040s.) was needed for their failed alternative to finally work its magic. Meanwhile, residents of our City are still at imminent risk from a Superfund/NPL site which was not remediated as promised.

After this failure, the Base/polluter should have sought to acquire the development rights to every potential development in the area described by the OU1 ROD and earlier by the Army Corps of Engineers. Those acquisitions could have been either continuous or conditional with an ending to equate with actual/verifiable remediation of the pollution at issue. However, it failed to so act. What has been done remedial since is seemingly little of real substance. Certainly nothing that will fully remediate this pollution problem in the foreseeable future (or "some uncertain time" projected to be in the 2040s).

How can valley residents cope with such failures and uncertainties? How should City Officials address them? State law and City ordinances mandate that Cities promote and protect the health and general welfare of "present and future residents." This is their most fundamental land-use responsibility. There is next to nothing it can do to help remediate the Base's pollution. However, all PPPs (which includes the City of South Weber) share the basic responsibility of conforming to the requirements cited in Federal statutes for protecting the public from hazardous materials which "have come to be located" on their 'facilities.'

Creating higher human density in the OU1 polluted areas, which were mostly rural when the 1998 ROD was finalized, undoubtedly creates more risk for exposures. Exposures require human receptors. Without them, there is obviously no chance of exposures. The pollution still exists. The various pathways, mainly provided by Mother Nature to potentially expose human receptors, still exist. However, until the City started creating numerous new subdivisions (against our strong objections), the risks were limited to the significant but relative few residents who already lived there at the time of the plumes creation. New and currently proposed/contemplated subdivisions could potentially increase the potential number of new human receptors to roughly 10 to 20 times higher than the amount of potential receptors living in the area in 1998. As stated above, besides putting themselves and their families at risk as potential human receptors, each new owner (and potentially any lenders financing the acquisitions) assumed a level of legal jeopardy as a Potential Responsible Party (PPP) due to his/her new ownership of a property where hazardous materials "have come to be located." Since ignorance of any kind is not well tolerated under CERCLA regarding PPPs; how should it be treated when at least comparable ignorance of pertinent facts is displayed in the oral and written records of a City Council and Planning Commission? Those officials, without doubt, have been the primary contributor for the increase in risk posed by the Base's pollution since the 1998 ROD was finalized. This is not to infer that those individuals are not generally well-intended and otherwise sometimes commendable for their public service. However, there is no conceivable excuse for them directly causing so much greater NPL-level risks for our present and future population, rather than striving to protect everyone from such risks.

Much like our military polluter, City officials also enjoy protections that might save them from legal jeopardy. Although they've made gross errors in preparations/judgments/decision-making which adversely affect the populations they have sworn to serve, they seem now to possibly be less at risk than all the hundreds of new PPPs they have placed in jeopardy because of their lack of proper preparation relating to the pollution matters at issue.

In summary, the status quo is a mess. The City and the polluter (with EPA and UDEQ participation) caused a huge problem. Rather than fewer potential human receptors of the Base's pollution and fewer PPPs facing legal jeopardy from the pollution on their properties, we now have more of both with many more still on the way. Failure has consequences. HAFB/EPA/UDEQ failed to produce the results (e.g.; resolution by about 2010) promised in their 1998 ROD. The Base's pollution sources still leak and all three concur that (even if their plans eventually work), full remediation is still decades away. Nevertheless, the City wrongly moved ahead as if the pollution issue was actually resolved. Both wrongdoers seem protected from most negative factors stemming from their misjudgments by various laws/regulations. Who serves those the wrongdoers needlessly placed at continued risk?

Protection, especially for the most vulnerable (old folks, pregnant women, young children), is a matter that hopefully the RAB can address. Moreover, while ignorance is frowned upon by CERCLA, it seems that the hundreds of new lot owners/PPPs are small fish compared to the City and the Base. Those bigger fish showed far worse judgment that the smaller fish. The largest mistake the smaller fish made seems to have been in giving undue credence to the misjudgments of the bigger fish. Hopefully, the RAB can address this imbalance too. Please let me know if you have questions.
