# Significant Events

# Significant Events

- ▶ December 13, 2019 / 0122 hours / Drug Offense
- ▶ An off duty Syracuse PD Officer called in to report a male smoking marijuana in the area of his neighborhood. The officer attempted to confront the suspect who began to resist him. Deputies responded and identified the suspect. He had been smoking marijuana out of a potato fashioned into a pipe. The suspect was booked for the offense and it was found that the pot-tato field tested positive for the presence of marijuana.

# Significant Events

- ▶ January 10, 2020 / 0950 Hours / Drowning
- ▶ 1 year old male drowned in the bathtub. Found and CPR done by paramedics. Pt started having agonal respirations then started breathing. Pt then started crying (poor quality) and transported to the hospital

# Significant Events

- ▶ January 16, 2020 / 0031 hrs / Suspicious
- ▶ Deputy M Castro located a white pickup parked at the pipeline gate on the east end of Cornia drive. The truck was unoccupied, but had the keys in the ignition, with wallet and money on the seat. A male stood up on the road above and began to yell down to Deputy M Casto. The male then walked away. Once contact was made with the male it appeared that he was having a psych problem. The male had parked at 0645 and left his vehicle. The male was not dressed for the weather and acting schizophrenic. The male was also on parole for Agg Arson. Ultimately the male was pinksheeted to McKay and his sister responded to take his truck.



# Significant Events

- ▶ January 17, 2020 / 1144 hours / Warrant Service
- ▶ Deputies were dispatched to a parking problem at this address. This home is being used as an air bnb. The complainant reported that several cars were parked on the street during the snowstorm. Also the complainant reported that the occupants were making lots of noise the night before. Arriving deputies spoke with the occupants at the home. One of the males provided several aliases and false names until he was successfully identified. He was identified by a Florida ID. He claimed to have taken a greyhound bus to the state from parts unknown. Upon positive ID it was discovered this male had a NCIC hit out of Indiana for aggravated assault. The NCIC hit was confirmed by dispatch. He was arrested and transported to jail.

# Significant Events

- ▶ January 26, 2020 / 2154 hours / Suspicious
- ▶ A running vehicle was found to be parked in the middle of the road with the driver side door open. The vehicle was found to be registered in the immediate area. The owner advised that the vehicle had been left unlocked with the keys inside. It appeared that this was a possible vehicle theft attempt, but the would be thieves were not able to operate the manual transmission and left it stalled out in the middle of the road. Extra patrol was provided with no suspects or additional victims located.

# Significant Events

- ▶ **February 10, 2020 / 2212 hours / Domestic**
- ▶ **Victim called in to report that her ex, who is the father of her children, had showed up at her home in an attempt to pick up the children. When she refused and did not answer the door, he forced entry into the apartment and proceeded to assault her in front of the children. He then attempted to take one of the children which the victim prevented and called for help. At that point the suspect fled the area and was later contacted and arrested by Deputies. He was booked for burglary, DV assault, DV in the presence of a child (x2) and custodial interference.**

# Significant Events

- ▶ March 6, 2020 / 0700 hrs-1100 hrs / SE side of South Weber
- ▶ 11 Vehicle burglaries from 2100 E South Weber Dr (Cambridge Apt) to Deer Run Dr. to 8300 S in South Weber. Basically scattered throughout the southeast side of South Weber. Possibly related to the stolen vehicle from South Weber used in the business burg at Get Some Guns. All vehicles were left unlocked and most were just rummaged through, with nothing of value taken. 10-14 right after the Get Some Guns burg another stolen vehicle out of Farmington was used to crash into Cal-Ranch and several guns were taken.

# Significant Events

- ▶ March 31, 2020 / 1908 hours / Domestic
- ▶ Victims called stating that the male suspect had come home angry stating that he wanted his gun to kill himself and everyone in the household. Approximately one week ago, they had found the suspect sitting in his vehicle in the driveway with the gun to his head. While deputies were responding, the male suspect left the home in his truck with a camper in the bed. Deputy Stimpson found the vehicle and attempted to make a traffic stop. He continued westbound on South Weber Dr without yielding, but was not evading. He obeyed all traffic laws and finally pulled over into the driveway of the Riverdale Drive In. Riverdale PD and Weber Co Sheriff's Office assisted with a high risk stop as it was unknown if he had possession of his gun. It was found that the gun was locked up in the home. He would not follow commands for several minutes, but eventually exited and complied. He was transported to Mckay for a mental commitment. No criminal charges are being sought.

# Significant Events

- ▶ **April 11, 2020 / 0024 hours / Residential Alarm**
- ▶ A residential alarm was dispatched for the above address. While Deputies were en route, dispatch was able to make contact with the homeowner who advised that his alarm had gone off and he found his front door to be open. Upon arriving in the area, a vehicle was seen leaving the neighborhood at a high rate of speed. Deputy Robinson was able to catch up to the vehicle and perform a traffic stop on I-84, the male driver stated he was “traveling”, refused to identify himself and then yelled profanities at Deputy Robinson and drove away. Deputy Robinson caught up to the vehicle a short distance further down I-84 where the vehicle stalled out and the male driver was taken into custody with assistance from several Weber County agencies and UHP. He was found to be in possession of methamphetamine, marijuana and paraphernalia. Upon further investigation at the residence (which was still taking place at the time of Deputy Robinson’s traffic stop), the home was found to be clear. It was noted that he has a ring doorbell camera as well as several other cameras around the exterior and interior of his residence. Further investigation is being completed.

# Significant Events

- ▶ May 2, 2020 / 1048 hrs / Aggravated Assault-Robbery
- ▶ Victim called to report he had been assaulted and money had been stolen from him. Deputy Reid arrived and found the suspect and victim on scene. The victim reported attending a party at the residence the night prior that included Alcohol and Marijuana use. The victim fell asleep and when he awoke he found \$800.00 missing from his wallet. He confronted the suspect and they got into an argument. The suspect then hit the victim over his head with a beer bottle, shattering it, then took \$100.00 from him while threatening him with the broken beer bottle. The shed at the rear of the residence where this took place appears to be set up to hang out in and had a large bong smelling of marijuana inside it. The suspect was arrested and charged with aggravated assault, aggravated robbery, and possession of CS

# Significant Events

- ▶ May 2, 2020 / 2321 hrs / (Axiom Construction) / Burglary IP
- ▶ The owners of Axiom Construction called to report that they could see a male inside of their building on live interior surveillance cameras, and then the cameras were suddenly disconnected. Before Deputies arrived, both owners who live near the area had responded and blocked in the suspect vehicle, a maroon Dodge Caravan with their vehicles. The suspect vehicle was found to be registered to a male who matched the description of the male seen on the surveillance footage. Deputies arrived shortly after, set up containment and cleared the building with the assistance of several outside agencies and a K9. The suspect was not located inside of the building or in the surrounding areas. It was noted that approximately \$20,000 worth of property from inside of the building was visible in the suspect vehicle. A search warrant was approved and the property was recovered and processed by crime lab. During this time, a report of a suspicious person trying to enter garages was called in the area of 1200 E 7600 S. The area was searched with a K9 and no suspect was located. The vehicle was impounded and it was confirmed that the suspect is homeless and appears to be living inside of the vehicle.

# Significant Events

- ▶ **May 4, 2020 / 1900 hrs / Summit County Sheriff's Office / Follow up**
- ▶ Deputies received a tip from an informant that the suspect from the Axiom Construction burglary was in the area of Park City. Contact was made with Summit County dispatch and Officers were able to take the suspect into custody. He was then transported to DCSO and booked for the related charges.

# Significant Events

- ▶ June 28, 2020 / 2212 hrs / Canyon Dr Air BnB / Shots Fired
- ▶ Several Deputies, Highway patrol and Kaysville PD responded to South Weber for the report of Shots Fired. Upon arrival several persons were interviewed but no one reported seeing any gun, any persons firing a gun or any injuries. It was found that a group of people had rented the house to make a Music video. Sometime during the night a fight broke out between several parties that were not invited. During the fight is when 3 Shots were allegedly fired in the roadway. No casing or other evidence could be located and all witnesses denied any knowledge or seeing a gun fired.



# Significant Events

- ▶ **July 5, 2020 / 1326 hours / Psych Eval**
- ▶ Deputies responded after the sister of the homeowner jumped from a window of the house, then returned inside and obtained a frying pan, threatened her sister with the cooking instrument and then exited the house again. She was transported to McKay Dee hospital for a psychiatric eval

# Significant Events

- ▶ July 14, 2020 / 1227 hours / Trespassing
- ▶ The female homeowner at this location called stating there was a male walking around in her backyard without a shirt. On the arrival of the first deputy, he found the male homeowner holding a shotgun and expelling the rounds out of it. He put the shotgun on the ground and stepped away. The male suspect was still on scene and had put his shirt back on. The homeowner stated he received a call from his wife stating an unknown male had been walking around their home. Upon his arrival, the unknown male was in the passenger seat of his vehicle. He grabbed his shotgun and told the male to leave. The male began yelling at him about the condition of his horses. The homeowner pointed the shotgun at low ready and told the male to get on the ground. The male refused and began to close distance to him. The homeowner began to back away while still giving commands. The male got close enough to grab the gun and a short struggle ensued. The homeowner was able to retain the gun and retreat. As he did so, the first deputy arrived. The suspect was found to be the same male who attempted to ride away on a donkey that he said he was going to buy. He has a history of controlled substance use. He was arrested for criminal trespass, vehicle burglary, and assault.

# Significant Events

- ▶ July 24, 2020 / 0415 hours / 7 vehicle burglaries
- ▶ Initial details were that one male wearing gloves was walking in front of a red Honda Civic and began checking doors of vehicles. Upon DCSO arrival, they had fled the area and the vehicle burglary reports started. Deputy Reid collected a good photo and video of the suspects. One of the photos shows a suspect picking up a handgun off the ground. Another video showed the suspect had possession of the firearm. All vehicles burglarized were unlocked and had been gone through. The Honda Civic was later reported stolen out of SW.

# Significant Events

- ▶ July 25, 2020 / 0003 hours / Noise
- ▶ A report of at least 30 individuals with underage persons drinking at a party in South Weber. Deputies responded and found approximately 20 individuals with 3 cars leaving prior. Several were under the age of 21 and had been consuming alcohol. One individual was also found to be in possession of marijuana. Multiple citations were issued and all parties were released on scene to family or other sober individuals.

# Significant Events

- ▶ August 1, 2020 / 1518 hours / Aggravated DV Assault
- ▶ Dispatch reported a physical male vs female assault occurring. Upon the deputy's arrival, he found a hostile male suspect and a female with obvious bruising to her face and neck. The victim was separated and stated she had been choked and thrown on the ground. The male suspect was taken into custody and booked in jail for aggravated DV assault



# Significant Events

- ▶ **August 5, 2020 / 2107 hours / DUI, Traffic Accident**
- ▶ Deputies were dispatched to a traffic accident involving injury. While en route, several bystanders reported that a male driving one of the involved vehicles had alcohol in the vehicle and was trying to cut his wrists with a pen. He then fled into a field on a property adjacent to the scene of the accident where bystanders held containment on him. Upon arrival, Deputies located the male and found him to be suicidal and DUI. He was transported to Davis Hospital, released on citation and pink sheeted. The vehicle that the suspect had rear ended was disabled and towed from the scene. The driver was evaluated and released by EMS.

# Significant Events

- ▶ August 9, 2020 / 0340 hours/ Reckless burning -Fire
- ▶ Multiple fire units responded to a fence on fire at the above address. The homeowner has an extensive history with law enforcement and had a shed burn in a fire in December of 2019. South Weber Fire Marshall believes the fire to be suspicious and the neighbors to the residence report an ongoing feud with the homeowner. After interviewing the suspect he was arrested for F2 Arson.

# Significant Events

- ▶ **August 11, 2020 / 2251 hrs / Agg Assault**
- ▶ A male suspect threatened his mother's boyfriend if he did not leave the property. The suspect said he would get a shotgun and hammer and shoot the boyfriend. While the caller was on the phone with dispatch, the suspect started shooting the shotgun at the trailer the boyfriend was staying in. The suspect was taken into custody and evidence of the shooting was collected. He was booked on Agg Assault x 2, Felony Discharge of a Firearm, and Threatening use of a dangerous weapon in a fight.

# Significant Events

- ▶ August 17, 2020 / 1914 hrs / Evade
- ▶ Deputy Brown performed a traffic stop on a motorcycle. The motorcycle initially stopped but then fled. Deputy Brown advised dispatch but did not pursue. A citizen that witnessed the incident knew the driver of the motorcycle and Deputy Brown was able to positively identify him as a resident of South Weber. Deputy Brown located the suspect with the motorcycle a short time later. He was arrested and the motorcycle was impounded.

# Significant Events

- ▶ August 26, 2020 / 0208 hours / Suspicious
- ▶ Deputy Sholly was parked, conducting extra patrol in the area and observed an older model, white SUV (possibly a Toyota rav4 or similar) driving slowly through the area consistent with the manner of the recent vehicle burglaries. When Deputy Sholly turned on his headlights to go and check on the vehicle, the driver turned off their headlights and sped out of the area. Several deputies responded and assisted in attempting to locate the vehicle but it was never located.



# Significant Events

- ▶ **September 6, 2020 / 0257 hrs / Accident**
- ▶ Deputy Robinson observed a vehicle off the roadway and discovered a 12 year old male in the vehicle uninjured. The 12 y/o male was identified. He had decided to go for a drive and since he was out was going to the store to get some things for the family. His parents were contacted and responded to the scene. No criminal charges being sought

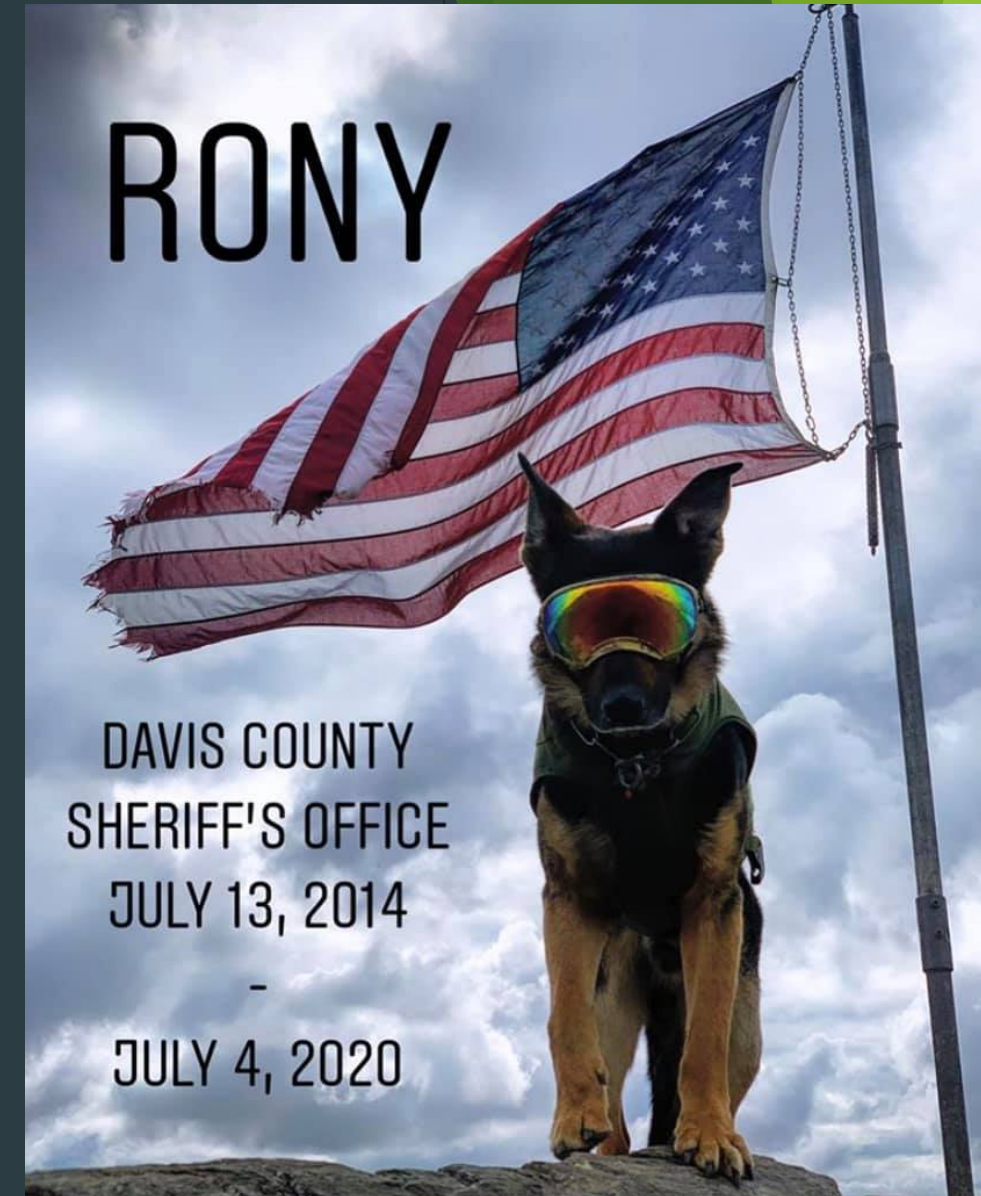
