

## RESOLUTION 22-30

### A RESOLUTION OF THE SOUTH WEBER CITY COUNCIL ADOPTING BUDGET AMENDMENTS FOR THE FISCAL YEAR ENDING JUNE 30, 2022

WHEREAS, Utah Code regulates the budgeting process for municipalities; and

WHEREAS, the city adopted its budget for fiscal year 2021-2022 on August 24, 2021; and

WHEREAS, the city desires to amend that budget with the referenced changes presented; and

WHEREAS, this legislative body held a public hearing on June 28, 2022 to take comment regarding the proposed amendments; and

WHEREAS, the City Council reviewed comments and discussed the presented changes in an open public meeting and is in favor of amending this budget;

**NOW THEREFORE BE IT RESOLVED** by the Council of South Weber City, Davis County, State of Utah, as follows:

**Section 1. Amendment:** The Fiscal Year 2021-2022 Budget shall be amended as follows:

10-57-120 Fire – Salaries and Benefits	\$ 65,000

20-34-757 Recreation – Soccer	\$ 4,000
20-71-210 Recreation – Subscriptions & Memberships	\$ 4,000


**Section 2: Repealer Clause:** All ordinances or resolutions or parts thereof, which are in conflict herewith, are hereby repealed.

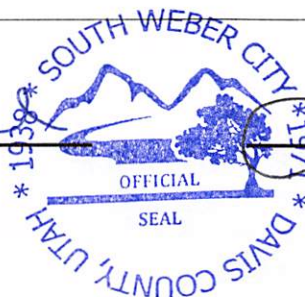
